- E. **Discussion and Action in Development of a Draft Work Plan.** IGM to present a first draft outline of a "Master Implementation Plan" with recommendations for a "First year Plan". This Work Plan is intended to address goals, schedule, budget, public outreach, and be broken into an annual program of practical and achievable milestones.
